Socialist Lobby Funds Sen. 'Kommie' Burton

Senator Burton, Say it Isn't so!

he tea-party senator who *appears* to lead the fight against creeping socialism in the Texas Legislature has herself been secretly funded by socialist lobbyists—including at least one agent of the Marxist government of Venezuela.

Sen. Konni Burton <u>announced</u> last week that her office will not meet with lobbyists who are paid tax money to lobby for governmental entities. Burton's accompanying statement noted that, "Many taxpayers don't even realize their own money is being used to pay lobbyists."

Indeed, the crafty commies have duped not just the taxpayers—but their elected representatives. Recalling Ronald Reagan's trust-but-verify approach to Soviet arms controls, *Lobby Watch* checked to ensure that socialist shysters had not infiltrated Burton's campaign.

There hiding in plain view on Burton's own campaign finance reports were no fewer than 18 lobby interests that, by their own confessions, received up to \$3.3 million during the 2013 legislative session to lobby for 76 different public-sector clients! This sleeper-cell of socialist lob-

byists gave \$25,550 of Bolshevik money to the Konni Burton campaign.

Burton's paymasters lobby for such infamous Comintern members as the lesbian-ruled City of Houston, the Brownsville *Public* Utilities Board and, naturally, the People's Republic of Austin. Led by the North Texas Municipal Water District, their clients even include socialist water suppliers that are in a position to adulterate the "precious bodily fluids" of millions of Texans.

Yet this is nothing compared to the \$500 that Burton took from Locke Lord, LLP, which lobbied for the Marxist government of Venezuela. During the 2013 session, Citgo Petroleum Corp. paid Locke Lord lobbyist Robert Miller up to \$25,000. Nowhere does Comrade Miller disclose that Citgo's true owner is Venezuela's *national* oil company: Petróleos de Venezuela.

Researchers could not immediately confirm Robert Miller's relationship to Marilyn-Monroeconsort Arthur Miller, the thespian who refused to hand over fellow commies to the House Un-American Activities Committee in 1956.

Learning from history, *Lobby Watch* is publishing a list of the public-sector lobbyists that bankroll Burton's campaign. Topping the list of the "Burton 18" is Ron Lewis, a publicly funded mole who served as a member of the Texas House for 17 blood-chilling years.

TPJ today calls on Lieutenant Governor Dan Patrick to appoint a special Senate Committee on Un-American Activities to ferret out every state official secretly financed by agents of socialism.

In the greatest threat facing the Republic since Generalissimo Santa Ana, public-sector agents have successfully infiltrated the public sector. Texas can purge this Communist cancer if it uses enhanced interrogation to persuade the "Burton 18" to finger their fellow travelers. Softness is socialism's enabler.
