Tax-Dodging Gas Producers Gave Politicos \$2 Million

exas politicians have shown little interest in rescinding a multibillion-dollar tax break for natural gas producers in a time of urgent need. It clarifies whose needs take precedence.

The tax exemption allowed gas producers to dodge more than \$1.5 billion in taxes during the two-year 2010 election cycle. During that same period Texas politicians collected \$1.5 million from the PACs and executives of Texas' top natural gas giants. The Texas Oil and Gas PAC doled out \$483,723 more, pushing the political payout to \$2 million.

Clearly the gas-tax exemption helps the folks who matter most: energy giants and politicians. Gas giants gave the most to Governor Rick Perry, even as they heavily backed gubernatorial challengers Bill White and Kay Bailey Hutchison.

They dug deep for Lieutenant Governor David Dewhurst and Speaker Joe Straus. And they curried favor with the Railroad Commissioners who are supposed to regulate them. They bankrolled Attorney General Greg Abbott and the Texas Supreme Court. And few corners of the Legislature escaped the frackers' reach.
