First Latina Secretary of State Led Voter-Suppression Drive

Perry's Chief Elections Officer Used 'Weak Matches' To Burn Not-Dead-Yet Voters. Will Andrade's Donors Want Refunds?

"Reports of my death have been greatly exaggerated." -the late Mark Twain¹

Secretary of State Esperanza 'Hope' Andrade and Attorney General Greg Abbott recently settled a voting-rights lawsuit filed by four voters whom Andrade prematurely suspected of dying.

As Texas' chief elections officer, Andrade directed local voting officials to notify 76,990 people that they would be purged from voting rolls before a major election unless they prove that they're alive. Andrade admitted that she based 89 percent of the names on her list on "weak matches" that loosely associated voter identification data with death records.²

Basing the majority of these names on weak matches suggests that this gubernatorial appointee was not content to stop corpses from voting. Texas' top elections official exceeded her mandate and went too far by sending long lists of garbage "weak matches" to voting officials. The *Houston Chronicle* found that one-third of the people on Andrade's Harris County blacklist "live" in historically black Precinct 1.³

Using weak evidence to try to disenfranchise voters attracts intense legal scrutiny in a state with a bitter history of race-based voter exclusion. Last month State District Judge Tim Sulak ordered a temporary halt to election officials purging Andrade-named voters. On the eve of a hearing to consider a permanent purging ban, Andrade settled the lawsuit. Where targeted voters previously had to prove they had a heartbeat to not be purged, now officials must prove death to purge a name.⁴

After Governor Rick Perry appointed her Secretary of State in 2008,⁵ Andrade raised \$134,391 in political contributions—even though she is not an elected office. Andrade taps her officeholder account to wine and dine, to buy gifts, to pay her phone bill and to pay accountants, fundraisers and other staff (see expenditure table below). Andrade loaned her officeholder account another \$5,000 last year.⁶ In her single largest expense, she blew \$9,218 on her 2008 swearing-in luncheon at Austin's Four Seasons Hotel.

Lobby Watch suspects some people who gave money to Texas' "first Latina Secretary of State" will be delighted with her discretionary choice to use "weak matches" to try to suppress voter turnout. Others may be disgusted.

Did voter suppression prompt ex-Clinton Housing Secretary Henry Cisneros to give Andrade \$250, for example? HEB Grocery chain CEO Charles Butt gave Andrade \$3,000. Does HEB—or its customers—approve of voter suppression schemes?

Many Andrade contributors hail from her hometown of San Antonio. Others are lobby interests tight with her gubernatorial patrón.

The table on the next page shows how much top contributors gave Andrade, as well as to Governor Perry and Attorney General Abbott. Abbott is the chief defender of Texas' legally challenged efforts to disenfranchise certain voters. Since Andrade started raising money in 2008, her top contributors have given \$830,808 to Abbott and almost \$2 million to Perry.

¹ Twain said this in 1897 to a reporter investigating rumors of his death. The Hope Andrades of Twain's day just flubbed their timing. Twain did indeed die 13 years later in 1910—one day after an earthly visit by Halley's Comet. Twain had been born during that comet's 1835 passing and had predicted that he would "go out with it."
