## Possible Abbott-Perry Rivalry Squeezes Wealthy Supporters

hen Rick Perry self-destructed on the presidential trail in late 2011 prospects for a 2014 gubernatorial shootout between Perry and Attorney General Gregg Abbott escalated—even though neither man has committed to the race yet.

Last year the duo raised a total of almost \$13 million, with Abbott pocketing 60 percent. Many of the same big donors have long supported both men. As the potential Perry-Abbott rivalry hit new heights last year, supporting one of these politicians increasingly suggested a snub of the other.

Dissecting this touchy subject, *Lobby Watch* assembled a list of the 42 top contributors who gave more than \$50,000 to Perry and/or Abbott last year (see next page). These elite donors gave

almost \$2 million to Perry and almost \$3 million to Abbott, accounting for 39 percent of all the money given to both politicians in 2012.

While homebuilder Bob Perry, AT&T PAC, highwayman James Doug Pitcock and HillCo PAC wrote comparable checks to both Abbott and Perry, relatively few of the top contributors took this diplomatic approach. Among the big donors who heavily favored one potential rival over the other, General Abbott commanded the early advantage.

Trial lawyer Anthony Buzbee is the only one of the 42 big contributors who failed to give Abbott anything in 2012. Meanwhile 15 big donors stiffed the governor last year. Rich folks who gave Abbott \$100,000 or more while giving Perry nothing include: beer magnate John Nau, Trammell Crow heir Howard Crow, deer-hunt rancher Stuart Stedman, oil magnates Ray Hunt and Nancy Hunt and investors Steven Hicks, T. Boone Pickens, Charles Tate and Ardon Moore.

Eight big contributors who gave much more money to Perry than Abbott in the 2010 election cycle overwhelmingly favored Abbott last year.

Conspicuous among them is Dallas billionaire Harold Simmons. Simmons gave almost \$1.2 million to Perry's gubernatorial campaigns as his Waste Control Specialists built a low-level nuclear waste dump in West Texas. Despite the fact that Perry's environmental appointees seem to approve Waste Control's every demand, Simmons gave \$35,000 to Perry and \$475,000 to Abbott last year. Radioactivity far outlasts even the most lucrative political relationships.

Others shifting the bulk of their support from Perry to Abbott include beer magnate John Nau, chemical honcho Reed Morian, retired phone executive Kenny Troutt, insurer Thomas Reiser and investors Steven Hicks, T. Boone Pickens and Charles Tate.

The attorney general pocketed 75 percent or more of all the money that 18 big contributors gave to both politicians in 2012 (this includes the 15 who gave Perry nothing). Just eight big donors gave at least three-quarters of their Perry-Abbott total to the governor.

As the longest-serving governor in Texas history, Perry's political-appointment patronage system has anchored his fundraising prowess. A 2010 <u>TPJ study</u> found that 20 percent of the \$83 million that Perry had then raised as governor came from one of the 4,000 people he had appointed to state office—or their spouses.

Six Perry appointees are top contributors to Perry and Abbott. Significantly, two of these Perry appointees gave nothing to Perry in 2012 (beer magnate John Nau and building materials purveyor John Lattimore). Gasoline retailer Clifton Thomas was the only appointee to give Perry more than 75 percent of all the money he gave to the two potential rivals. The other three appointees (auto kingpin T. Dan Friedkin, refinery mogul Paul Foster, and Caterpillar equipment dealer Peter Holt gave substantial amounts to both Abbott and Perry).

Both Perry and Abbott got 70 percent or more of all the money they raised last year from whopper checks of \$10,000 or more. Checks worth from \$10,000 to \$50,000 accounted for 53 percent of Perry's money, compared to just 36 percent of Abbott's total. Abbott relied more on both bigger and smaller checks. Checks of less than \$5,000 delivered 17 percent of Abbott's money and 12 percent of Perry's total. Meanwhile one-third of Abbott money came from huge checks of \$50,000 or more, compared to just 22 percent of Perry's total.

Doctor-owned hospital interests wrote both of Perry's two biggest checks: North Cypress Medical Center (\$355,000) and Border Health PAC \$100,000). Harold Simmons wrote Abbott three huge checks totaling \$475,000. Abbott also got six-figure checks from Howard Crow, Steven Hicks, Kenny Troutt, John Nau, Boone Pickens, Stuart Stedman and Charles Tate.
