Sibley Asks Voters To Rehire a Hired Gun

Bible-Belt Baptists Hash It Out: How Many Times Should Lawmakers— Or Church Casseroles—Be Resurrected, Reheated and Reincarnated?

The massive, seasonal migration of lawmakers into the lobby blinds us to how rare it is for lawmakers to leave the legislature, make money in the lobby and then return to the legislature with enriched perspectives.

Nine ex-lawmakers have reentered the legislature since 1995, according to the Legislative Reference Library. Just two of these lawmakers registered as lobbyists before their reentries.

Rep. Tracy King reported nine lobby contracts worth up to \$135,000 while on his two-year sabbatical.

shallow waters. Since leaving the Senate in 2002, Sibley reported 239 contracts worth up to a stunning \$15.6 million.

The Texas Legislature is a farm team for lobbyists. Less often, wealthy, well connected lobbyists run for public office, enjoying huge fundraising advantages. Sibley raised \$480,627 in less than two months, dominating the four-way special election for retiring Senator Kip Averitt's seat. Sibley's war chest is almost seven times that of his closest rival: Republican Brian Birdwell.

During his 12-year hiatus, colleague Todd Hunter landed 73 contracts worth up to \$2.8 million.

If David Sibley rides his unrivaled war chest to a Senate victory on Saturday, as expected, he will blow Hunter and King out of these

Many Sibley clients are excited about sending one of their lobbyists to the Senate. Just 31 big contributors gave \$230,972 Sibley accounting for half his total war chest. Ten of these big donors are exclients who together paid Sibley up to million \$4.3 to lobby.

Then-Lieutenant Governor Rick Perry put Sibley in charge of the 1999 Senate committee that Sibley used to help deregulate Texas' electricity markets. Although Enron's Kenny Boy Lay has departed, other promoters of that consumer fleecing now back Sibley's campaign. Former Rep. Steve Wolens, the dereg architect in the House, gave Sibley \$2,500. Then-Governor George W. Bush gave \$2,000. As deregulation began to hit electricity rates—like summer sun on mercury—Sibley hit the revolving door. The Energy & Natural Resources sector quickly became his biggest cash cow, accounting for 19 percent of the up to \$15.6 million that he billed clients. His No. 1 client in this sector was the Association of Electric Companies, which fought to give its members deregulatory windfalls.



Sibley's No. 3 career client is Lorillard Tobacco, the maker of the nation's best-selling menthol cigarettes. Lorillard and Swedish Match (which produces cigars and snuff) collectively paid Sibley up to \$250,000 last year, making him the No. 1 tobacco lobbyist in Texas.¹ Last year the industry snuffed efforts to ban smoking in workplaces and public spaces.²

Led by State Farm, insurance was the No. 3 industry clamoring for Sibley's lobby services. State Farm has done more than anyone to publicize Texas' inability to regulate insurers. The company triggered Texas Department of Insurance protests last year when it announced a 9 percent increase in homeowner rates. State Farm was so moved by this regulatory posturing that it recently announced rate hikes of another 4.5 percent.³ For years, State Farm has got the better of Texas regulators, who settle complaints about its "excessive" rates for pennies on the dollar.⁴

As part of the Department of Insurance's supervision of one Sibley client, state regulators co-signed every major check that troubled auto insurer Universal Insurance wrote. The *Texas Observer* recently reported that—in a dazzling display of clout— Universal's payments of \$255,000 to Sibley were cosigned by the very regulators that he was hired to lobby.⁵ Late last year the state sued Universal's former owner, Sibley client Kourosh Hemyari, for allegedly taking \$4.8 million in improper fees from policyholders.

David Sibley is by far the most experienced candidate on the Senate District 22 ballot. Some of that experience is the kind that only big money can buy.
