# Chewing Over A Chaw Tax Cut

# Smokeless Tobacco Industry Spat Up To \$4 Million into Texas Lobby. Texas Republican Party and Rick Perry Pinch the Most Tobacco Money.

he populist Texas House solved the greatest tax-equity issue of the 82<sup>nd</sup> legislative session, forwarding it to the elitist Senate—where its future is uncertain. In one of this century's great injustices, Texas lawmakers decided in 2009 to tax smokeless tobacco by weight rather than value. This hammered folks who prefer a big wad of tobacco to an effeminate pinch of concentrated dip.

The tax change cut Texas' chewing tobacco sales by 50 percent, according to Stockholm's Swedish Match.<sup>1</sup> That blond, Scandinavian company markets Redman Chewing Tobacco, America's No. 1 brand.

Some lawmakers won't allow tax policies to reduce consumption of carcinogens. Fresh from his recent switch to the manlier Republican Party, Allan Ritter of

Nederland introduced House Bill 2599, which slashes chewing tobacco taxes from \$1.13 per ounce to 80 cents.<sup>2</sup> Ritter said the bill is "good" for "all of us that chew tobacco."<sup>3</sup> But that's just Ritter's chaw talking. At least 28 carcinogens found in smokeless tobacco cause oral, esophageal and pancreatic cancer, according to the National Cancer Institute.<sup>4</sup> Ritter's bill is bad for consumers and for Texas, which subsidizes those chewing-tobacco users who can't afford to pay their own way with mouth cancer.

Still, Ritter's bill *is* good for chewing tobacco producers, who have chafed under the 2009 tax structure that tobacco snuff producers spent at least eight years orchestrating.<sup>5</sup>

*Lobby Watch* tracked smokeless tobacco money, which quickly led to smoke-filled rooms. Joe Camel's Reynolds American acquired the American Snuff Co. and its Grizzly and Kodiak brands in 2006.<sup>6</sup> Marlboro Man's Altria Group inhaled U.S.

Smokeless Tobacco Co. (UST) in 2009. With its premium Copenhagen and Skoal snuff brands, UST was a major advocate for—and beneficiary of—Texas' 2009 tax change.

During a House committee hearing in March, tobacco giants Altria and Reynolds did not publicly take positions on HB 2599. Presumably their attitudes hinge on whether or not increasing chewing-tobacco sales, as Ritter has prescribed, will cannibalize their own snuff markets.<sup>7</sup> *Lobby Watch* was unable to answer this question by press time.

It's also possible that Ritter took the tobacco giants by surprise. Ritter slipped the tax cut into his bill just before the House hearing, tripping up even veteran lobbyists. The Texas Medical Association told *Lobby Watch* that it registered *for* the bill based on its original language but is fighting the latest version that slashes taxes on known carcinogens.

With a Senate Finance Committee hearing scheduled on Ritter's bill tomorrow, perhaps the tobacco giants will weigh in on the bill or a brave senator might be able to smoke out where they stand. The issue could be crucial, given that Altria and Reynolds dominate tobacco politics in Texas.

The smokeless tobacco lobby spent up to \$4 million on 62 Texas lobby contracts over the past two years, with Altria and Reynolds accounting for 75 percent of the total.

The top interests pushing Ritter's bill are Swedish Match, North Atlantic Trading Co. (Beech-Nut chew) and Swisher International (Mail Pouch chew). Since last year these three chaw interests have spent up to \$910,000 on 16 lobby contracts. Tantus Tobacco and Cheyenne International, which testified against Ritter's bill, reported their first modest Texas lobby contracts in 2011.<sup>8</sup>

Texas' top tobacco lobbyists include ex-lawmakers Stan Schlueter and Bill Messer, as well as a couple of Governor Rick Perry's former lieutenants who joined the lobby: Reggie Bashur and Luis Saenz.

The smokeless tobacco industry also gave \$197,548 to Texas state candidates and political committees in the 2010 election cycle. It directed two-thirds of the total to the Texas Republican Party and Governor Perry. Altria gave \$100,000 in corporate funds to the GOP, while Governor Perry collected \$31,004 from tobacco interests led by Altria's UST PAC.

The chewing-tobacco lobby did not supply any of the contributions tracked here. In fact, Altria and its UST unit contributed almost all the political money. Tantus Tobacco President Brian Cooper of Kentucky also gave \$1,000 apiece to Senator Jose Rodriguez and Reps. John Otto, Jim Pitts and Rene Oliveira. He gave another \$750 to Rep. Senfronia Thompson.
